

WELCOME TO UNITY 2015!

I am proud and honored to welcome you to Americans for Safe Access' (ASA) third annual National Medical Cannabis Unity Conference and Citizen Lobby Day! This weekend you will meet some of the most effective and important patients, advocates, doctors, researchers, industry workers, and other stakeholders in the evolving field of medical cannabis. We have an amazing group of speakers lined up to share with you both





You will also get an insider's view on groundbreaking medical cannabis legislation, which is now on the table in the US Senate and the House of Representatives. On Tuesday, you will be a part of an annual citizen lobby day that has already made a big impact on medical cannabis on the national level. This is your chance to have your voice heard in the halls of Congress and make a real difference in achieving our goal—safe, legal, and dignified access to medical cannabis for everyone who needs it.

When we founded ASA in 2002, there were seven states with medical cannabis laws on their books, about 30,000 legal patients, and only eleven distribution centers in the entire country – all of which were under attack by the US Department of Justice. Today, there are over two million legal medical cannabis patients, over 2,000 medical cannabis distribution centers, and thirty-six states and the District of Columbia have passed medical cannabis laws. With the help of the American Herbal Products Association and the American Herbal Pharmacopoeia, we now have the tools we need to properly regulate medical cannabis as a mainstream herbal medicine – accessible and acceptable to a broad swath of the American public.

Our movement has momentum and energy right now. We can see real progress on the state and federal level. Congress is debating meaningful legislation for the first time; state policy makers are moving towards inclusive laws, which facilitate broader access; and millions of dollars are flowing into cannabis research. The cultivation, processing, distribution, and testing of medical cannabis are increasingly in line with contemporary product safety standards for herbal medicine in the United States.

It is a proud time for our movement, but our struggle is not over. This moment in history demands our full commitment. To bring safe and legal access to this nation through evidence-based policies, we must prepare ourselves to guide the changes already underway. A new Congress is considering legislation that could end the state and federal conflict once and for all. This is why the theme of this year's Unity Conference is "Wellness is Winning: Advancing Evidence-Based Medical Cannabis Policy."

Thank you for joining us in Washington, D.C. to celebrate our many achievements and prepare for the future. Together, we can ensure safe access for all medical cannabis patients.



The PFC Enrichment Courses program allows you to take targeted cannabis training to expand and deepen your understanding of Cannabis gardening, pest management and laboratory protocols. Offered as one (1) hour deep dives, participants can choose to participate in one (1) or all of the advance cannabis training.

ASA 201: Sustainable Gardening (1 hour) 8:30 am - 9:30 am

Cannabis cultivation can and should be managed utilizing environmentally friendly procedures and practices. In this course learn how to reduce your cultivation sites water use, medium waste, and nutrient use while also reducing your overall carbon footprint. Whether you are cultivating indoors, in a green house or open air this course covers the steps necessary to operating within the caring capacity of the environment you work in.

ASA 202: Pesticide Use and Integrated Pest Management (1 hour) 9:45 am - 10:45 am

Cannabis, like other agricultural crops, can become subject to pest and disease issues leading farmers to sometimes rely on the use of pesticides during the crops life cycle. This one hour course will focus on two specific areas of pesticide use. In the first portion of the course learn how to effectively read a pesticide label including understanding tolerance thresholds, toxicity categories, chemical families, and established reentry times. The second portion of the course is designed to help cannabis farmers understand the key components to developing a successful Integrated Pest Management (IPM) plan. Through the use of IPM plans farmers can vastly reduce, if not completely eliminate, their reliance on pesticide use.

Sara Arnold, aka Sahra Kant, is a drug policy advocate committed to ending the persecution of pregnant women and parents (of all genders) for cannabis use in criminal or civil matters. She has been

active in the drug policy movement on local, national and international levels since her teens. Her positions have included Media Contact (Scotland) for the UK's Legalise Cannabis Alliance (now CLEAR), Director and Social Media Maven for MassCann/NORML, and Family Issues columnist for Mass Grass newspaper. She is currently Vice-Chair of Students for Sensible Drug Policy's national Outreach, Recruitment & Diversity Committee and is Co-Founder of the Family Law & Cannabis Alliance. She has spoken at conferences and festivals as well as several universities and law schools: her panel at Harvard was one of National Advocate for Pregnant Women's "Reproductive Justice Moments of 2012." Arnold is a mother of two little girls and has faced Child Protective Services three times over medical marijuana use.



Bianca Barnhill was a successful model for Ralph Lauren and Giorgio Armani for 15 years before her career was cut short by a diagnosis of ColoRectal cancer. Two years post-cancer she discovered cannabis

as an alternative to the 13 medications she was taking. Since making this discovery and meeting other patients, Bianca has worked for her family's magazine *High Times* as a West Coast Correspondent, utilizing her mainstream network to speak out on this issue. In that time she has gotten Melissa Ethridge, Oliver Stone, Snoop Dogg, Wiz Khlaifa, NAS, and Damien Marley to do interviews. As she became an activist, she found ASA shared her personal mission to change laws and create new rights by bringing the patients voice to the struggle for safe and legal access. She is a member of ASA's Board of Directors.



Larry Bedard, M.D., F.A.C.E.P., is a partner with California Emergency Physicians and serves on the staffs of St. Mary's Hospital in San Francisco and San Mateo General Hospital. Dr. Bedard is a delegate

to the California Medical Association and past President of the American College of Emergency Physicians. He was the Co-chair of the Health Professionals Steering committee for California's Proposition 19, and he was key in getting the California Medical Association to officially support organ transplant approvals for patients who use medical marijuana.



Yami Bolanos is a 59-year old organ transplant survivor and medical cannabis patient who is fighting to prevent discrimination in the organ transplant process in California as a spokesperson

for AB 258 in the state legislature. Bolanos is also a patient-operator of one of the collectives qualified to operate under Measure D in Los Angeles and the President of the Greater Los Angeles Collectives Alliance (GLACA). GLACA is the oldest medical cannabis trade association in California and represents 59 legal medical cannabis facilities in the LA area.



Marcel O. Bonn-Miller, Ph. D., is a Research Health Science Specialist at the National Center for PTSD and Center for Innovation to Implementation at the VA Palo Alto Health Care System as well as

Center of Excellence in Substance Abuse Treatment and Education at the Philadelphia VAMC, and Adjunct Assistant Professor in the Department of Psychiatry at the University of Pennsylvania Perelman School of Medicine. He received his B.A. and Ph.D. in Clinical Psychology from the University of Vermont and was a Postdoctoral Fellow at Stanford University School of Medicine. Dr. Bonn-Miller has dedicated his career to understanding the interrelations between cannabis use and PTSD symptomatology, with the aim of informing intervention and prevention strategies. Dr. Bonn-Miller is internationally recognized as a leading expert in the study of cannabis use among individuals with PTSD. He has served as PI or Co-I on dozens of grants varying from experimental laboratory-controlled to prospective outcome studies, including a VA Career Development Award. Approximately 50 of his 98 peer-reviewed publications have investigated cannabis comorbidity, most with a focus on PTSD.



Stephen B. Corn, M.D., Founder of TheAnswerPage and Director of Clinical Innovation at Harvard Medical School is a board certified physician of Brigham and Women's Hospital and Children's

Hospital, Boston, Massachusetts and Professor at Harvard Medical School. He specializes in anesthesiology, pain and perioperative medicine. He is also a prolific inventor and holds over 30 United States and international patents. His expertise in medical devices has resulted in his being named the first "Director of Clinical Innovation" for Boston Children's Hospital and Brigham & Women's Hospital, Harvard Medical School. Dr. Corn has donated technology appraised at over \$6 million to Brigham & Women's Hospital, Harvard Medical School and Women & Infant's Hospital, Brown University. Dr. Corn co-founded TheAnswerPage.com in 1998 to provide daily education to doctors and other healthcare professionals. The Answer Page is read in over 120 countries, has granted well over 100,000 hours of AMA PRA Category 1 CME Credits™ and offers an industry-unique interactive crossword puzzle for a fun and effective learning experience. In 2013, TheAnswerPage launched the continuing medical education program (CME) entitled, "Medical Marijuana - Medical, Legal, Social and Political Issues." Dr. Corn is the recipient of numerous awards and was included in "Champions in Health Care" by the Boston Business Journal. In 2014, he was named ASA's "Medical Professional of the Year."



Anastacia "Stacia" Cosner is the Deputy Director for Students for Sensible Drug Policy, where she is responsible for management, finances, administration, event planning, program implementation,

development, communication, and data. While a sophomore at the University of Maryland in 2006, Stacia spent her summer in the national SSDP office as an intern. She was hired as an Outreach Director in June 2009, promoted to Associate Director in January 2011, then to Deputy Director in June 2013. Prior to that, Stacia completed internships with Students for Sensible Drug Policy (2006), the Marijuana Policy Project (2007), the Institute for Humane Studies (2008), and DRCNet/StopTheDrugWar.org (2009).



Rick Doblin, Ph.D. is the founder and executive director of the Multidisciplinary Association for Psychedelic Studies (MAPS). He received his doctorate in Public Policy from Harvard's Kennedy

School of Government, where he wrote his dissertation on the regulation of the medical uses of psychedelics and marijuana and his Master's thesis on a survey of oncologists about smoked marijuana vs. the oral THC pill in nausea control for cancer patients. His undergraduate thesis at New College of Florida was a 25-year follow-up to the classic Good Friday Experiment, which evaluated the potential of psychedelic drugs to catalyze religious experiences. He also conducted a thirty-four year follow-up study to Timothy Leary's Concord Prison Experiment. Rick studied with Dr. Stanislav Grof and was among the first to be certified as a Holotropic Breathwork practitioner. His professional goal is to help develop legal contexts

for the beneficial uses of psychedelics and marijuana, primarily as prescription medicines but also for personal growth for otherwise healthy people, and eventually to become a legally licensed psychedelic therapist. He founded MAPS in 1986, and currently resides in Boston with his wife and three children.



Don Duncan has served on the Board of Directors since he co-founded American for Safe Access in 2002. As California Director, he is coordinating the grassroots and grasstops campaign to fully imple-

ment the states medical cannabis laws, respond to federal interference, and build a broader and more powerful coalition for medical cannabis in California. Don was instrumental in galvanizing grassroots resistance to federal raids and in seeding local self-regulatory alliances for medical cannabis providers statewide. He has worked closely with elected officials, law enforcement, collective operators, and community members in local implementation efforts in several California cities and counties, and is currently working with lawmakers in Sacramento to adopt legislation to expand rights for patients. Don co-founded one of the oldest and most reputable families of medical cannabis dispensing collectives in California, helping to open legal facilities in Berkeley, West Hollywood, and Los Angeles. He is a medical cannabis consultant and has been featured in major media coverage of the issue.



Mike Folmer, a Pennsylvania State Senator. is a founding member of the Constitutional Organization of Liberty, a project to promote awareness of America's founding principles. Along with

Senator Daylin Leach, Folmer is sponsor of Senate Bill 3, the Compassionate Use of Medical Cannabis Act, which would allow Pennsylvania physicians to prescribe medicinal cannabis. He has led a bipartisan effort to give patients access to medical cannabis, which has been proven effective across the nation in treating many disorders but is not legal in Pennsylvania. He currently serves as Chairman of the Senate State Government Committee and Vice Chairman of the Education Committee. Other committee assignments include Intergovernmental Operations; Labor and Industry; Communications and Technology and Rules and Executive Nominations.



Jeffrey Hergenrather, M.D. is a general practitioner specializing in cannabis consultations since 1999. His medial experience includes 26 years in emergency medicine and private general practice that

includes use of cannabis as medicine since 1977. He continues in an active consultation practice in



California that includes telephone and online consultations in using cannabis for medical problems. Dr. Hergenrather is a founding member of the Society of Cannabis Clinicians developing educational programs and clinical studies with physician members of the Society. He is a member of the International Cannabinoid Research Society (ICRS) as well as the International Association for Cannabinoids in Medicine (IACM), where he serves on the scientific advisory committee. Dr. Hergenrather has worked with local governments in creating safe access to cannabis medicines.



Hunter Holliman is currently Chief of Staff for Americans for Safe Access. After completing his Masters in Human Rights, Hunter came to ASA through his involvement with the San Francisco Chapter.

Having been a patient in California for nearly a decade, he also has a background in dispensary work and served on the San Francisco Medical Cannabis Task Force. Hunter relocated to Washington, DC in late 2012 to work as ASA's National Field Coordinator.



John Hudak, Ph.D., is a fellow in Governance Studies at the Brookings Institution and Managing Editor of the FixGov blog. His research examines questions of presidential power in the contexts

of administration, personnel, and public policy. Additionally, he focuses on campaigns and elections, bureaucratic process, legislative-executive interaction and marijuana policy. He is the author of the new book, *Presidential Pork*.



Rabbi Jeffrey A. Kahn, M.A.H.L., D.D., Founder of Takoma Wellness Center, has three decades of experience serving as the spiritual leader of four synagogues – in Adelaide Australia, Rockford Illinois,

Miami Florida, and Central New Jersey. Ordained a Rabbi on June 5, 1981 – the day the CDC reported the first AIDS patient – he devoted his career to ministering to families and individuals struggling with the devastating effects of serious illnesses. Rabbi Kahn has been fully engaged in the development of Takoma Wellness Center since 2010 and now works full-time at the center.



Pavel Kubu, M.D., Founder of Konomed Ltd., is an expert in medical informatics and addiction. Since 2005, he has worked for Intel Corporation as a Business Development Manager leading projects

of Intel World Ahead Program for Healthcare in Central and Eastern Europe and Education in the Czech Republic and Slovakia. In 2006, Dr. Kubu was appointed as chairman of the Ethical Commission at the National Monitoring Center for Drugs and Drug Abuse. Dr. Kubu has served as a board member of the Czech National Forum for Health since 2007, and as a steering committee member of Czech Healthcare Forum since 2012. He has also been a board member of medical cannabis patient organization KOPAC. Since 2011, Dr. Kubu has been leading medical strategy implementation at Elon Medical, a company devoted to the R&D of wearable plastic electronics. In 2014, Dr. Kubu founded Konomed Itd., a company focused on clinical research and innovations in the field of

medicinal cannabis. In March 2015, he also became a founding member of International Medical Cannabis Patient Coalition.



Martin A Lee is the director of Project CBD (projectcbd.org), an educational service that focuses on cannabis science and therapeutics. He is the author of *Smoke Signals: A Social History of Marijuana* –

Medical, Recreational and Scientific, winner of the American Botanical Council's James A. Duke Award for Excellence in Botanical Literature. Lee is also cofounder of the media watch group FAIR (Fairness & Accuracy In Reporting) and the author of Acid Dreams and The Beast Reawakens.



Mike Liszewski, J.D., is the Government Affairs Director at Americans for Safe Access. He spent his early career as a community organizer for Banner Neighborhoods in southeast Baltimore,

MD, forming after-school reading, art, sports and employment programs for elementary and middle school-aged youth. As a law student, he helped lead a successful lobbying campaign that defeated an ill-conceived "gang injunction" bill, and clerked in DC Council Committee on Health as it was considering B18-622, the District's medical cannabis law. Mike served as a student member of SSDP's Board of Directors (2010-2012) and the ACLU-NCA (2010-2011). Shortly before joining ASA's staff, Liszewski co-drafted the original version of what was eventually passed and signed into law in D.C. as the Good Samaritan Overdose Prevention Amendment Act of 2012. As Government Affairs Director at ASA, he works with patients, advocates, and elected officials at the state, local and national level to create new laws and improve existing ones that allow patients to have safe access to medical cannabis therapy. Liszewski has also been actively involved with the implementation process to make sure these laws result in patients having legal and affordable access to medicine.



Jahan Marcu, Ph.D. is currently the Senior Scientist and Chief Auditor for Americans for Safe Access and the Patient Focused Certification (PFC) Program. His is also on the Board of Directors of the

International Association for Cannabinoids as Medicine (IACM). Dr. Marcu is the Director of Research and Development at Green Standard Diagnostics Inc. His doctoral research concerned the structure and function of the CB1 receptor, and the role of the endocannabinoid system in bone. Before earning his Ph.D., Dr. Marcu worked at the California Pacific Medical Center Research Institute studying the

anti-cancer properties of compounds from the cannabis plant (published in the Journal of Molecular Cancer Therapeutics) and on analytical Cannabis research projects in Holland. He is also an author of the American Herbal Pharmacopeia's Cannabis Monograph. Dr. Marcu is a recipient of the Billy Martin research award from the International Cannabinoid Research Society. Dr. Marcu is a contributing author or editor or both of several publications including: O'Shaughnessy's: The Journal Of Cannabis in Clinical Practice (beyondthc.com), projectCBD.org, the West Coast Leaf (aka the Leaf), the Philadelphia Examiner (www.examiner.com), CannabisNow, the sensible science blog at freedomisgreen.com, and Freedom Leaf Magazine. Dr. Marcu is also court qualified cannabis and synthetic cannabinoid expert.



Michael McGuffin is the president of the American Herbal Products Association (AHPA) and has been active in the herbal industry since 1975. He has owned and managed both retail and

manufacturing businesses in this field. Michael also serves on the boards of the American Herbal Pharmacopoeia and United Plant Savers, and on the Advisory Board of the USC School of Pharmacy Regulatory Science Master's Degree Program. In addition, he is the managing editor of AHPA's Botanical Safety Handbook, first (1997) and second (2013) editions, and of Herbs of Commerce, 2nd edition (2000). Michael was presented the Cliff Adler "Heart in Business" award in 1994 and the Nutrition Business Journal Award for Efforts on Behalf of Industry in 2004 and in 2011. He was inducted into New Hope Natural Media's "Hall of Legends" in March 2013.



Kristin Nevedal is the Director of the Patient Focused Certification Program. Before joining ASA she co-founded and served on the board of the Emerald Growers Association whose mission is to

promote the medicinal, environmental, social, and economic benefits of lawfully cultivated sun-grown medical cannabis. As chair of the American Herbal Products Association Cannabis Committee's Cultivation Working Group, Nevedal assisted in the development of cannabis cultivation model regulations and best practices for agency consideration. She is also an instructor at Oaksterdam University, teaching classes on environmental sustainability and Best Management Practices. Nevedal serves as a board member for the Coalition for Cannabis Policy Reform, Californians to Regulate Medical Marijuana, Americans for Safe Access's Patient Focused Certification Program, and the 420 Archives.



Alice O'Leary-Randall is the widow of Robert C. Randall, the acknowledged founder of the medical cannabis movement. She lives in Sarasota, Florida and is a retired hospice nurse. Since retirement,

she has returned to the fight for medical cannabis on many fronts, including as an Ambassador for Mary's Medicinals. She is the author of *Medical Marijuana in America: Memoir of a Pioneer*. She will be signing copies of her book on Saturday from 3:30-4:00.



Bill Piper is the director of Drug Policy Alliance's office of national affairs in Washington, D.C., where he is responsible for developing and implementing strategies for ending the federal war on drugs.

He lobbies Congress in support of cutting drug war waste, protecting state marijuana laws from federal interference, reforming draconian sentencing laws, restructuring federal law enforcement agencies, and preventing drug overdoses and the spread of HIV/AIDS and hepatitis C.



Amanda Reiman, Ph.D. is Manager of Marijuana Law and Policy at the Drug Policy Alliance, where she works to develop DPA's marijuana reform work as it relates to litigation, legislative and initia-

tive drafting, campaign strategy, policy advocacy, media relations, fundraising, and public education in the local, state, federal, and international jurisdictions in which DPA is active. Reiman joined DPA in 2012 after working with Berkeley Patients Group, a renowned medical marijuana dispensary, as director of research and patient services.



Ethan Russo, M.D., is a board-certified neurologist, psychopharmacology researcher, and Medical Director of Phytecs. Previously, from 2003-2014, he served as Senior Medical Advisor and

study physician to GW Pharmaceuticals for three Phase III clinical trials of Sativex® for alleviation of cancer pain unresponsive to optimized opioid treatment and initial studies of Epidiolex® for intractable epilepsy. Dr. Russo graduated from the University of Pennsylvania (Psychology) and the University of Massachusetts Medical School, before residencies in Pediatrics in Phoenix, Arizona and in Child and Adult Neurology at the University of Washington in Seattle. He was a clinical neurologist in Missoula, Montana for 20 years in a practice with a strong chronic pain component. In 1995, he pursued a 3-month sabbatical doing ethnobotanical research with the Machiguenga people in Parque Nacional del Manu, Peru. He joined GW as a full-time consultant in 2003. He has held faculty

appointments in Pharmaceutical Sciences at the University of Montana, in Medicine at the University of Washington, and as visiting professor at the Chinese Academy of Sciences. He is Past-President of the International Cannabinoid Research Society and former Chairman of the International Association for Cannabinoid Medicines. He serves on the Scientific Advisory Board for the American Botanical Council. Dr. Russo is author of Handbook of Psychotropic Herbs, co-editor of Cannabis and Cannabinoids: Pharmacology, Toxicology and Therapeutic Potential, and author of The Last Sorcerer: Echoes of the Rainforest. He was founding editor of Journal of Cannabis Therapeutics, selections of which were published as books: Cannabis Therapeutics in HIVIAIDS, Women and Cannabis: Medicine, Science and Sociology, Cannabis: From Pariah to Prescription, and Handbook of Cannabis Therapeutics: From Bench to Bedside. He has also published numerous book chapters, and over thirty articles in neurology, pain management, cannabis, and ethnobotany. Suzanne A. Sisley, M.D., practices medicine in Scottsdale, AZ and specializes in Internal Medicine and Psychiatry. She is widely known for her research into potential medical uses of marijuana to

treat veterans diagnosed with PTSD. Her research is supported by the Multidisciplinary Association for Psychedelic Studies (MAPS), a California-based nonprofit organization. Dr. Sisley serves as Principal Investigator for the only FDA-approved randomized controlled trial looking at use of whole-plant marijuana (grown by NIDA) in combat veterans with treatment-resistant post-traumatic stress disorder PTSD. 



Choose from the following courses:

ASA 201: Sustainable Gardening (1 hour) 8:30 am - 9:30 am

Cannabis cultivation can and should be managed utilizing environmentally friendly procedures and practices. In this course learn how to reduce your cultivation sites water use, medium waste, and nutrient use while also reducing your overall carbon footprint. Whether you are cultivating indoors, in a green house or open air this course covers the steps necessary to operating within the caring capacity of the environment you work in.

ASA 202: Pesticide Use and Integrated Pest Management (1 hour) 9:45 am - 10:45 am

Cannabis, like other agricultural crops, can become subject to pest and disease issues leading farmers to sometimes rely on the use of pesticides during the crops life cycle. This one hour course will focus on two specific areas of pesticide use. In the first portion of the course learn how to effectively read a pesticide label including understanding tolerance thresholds, toxicity categories, chemical families, and established reentry times. The second portion of the course is designed to help cannabis farmers understand the key components to developing a successful Integrated Pest Management (IPM) plan. Through the use of IPM plans farmers can vastly reduce, if not completely eliminate, their reliance on pesticide use.

ASA 203: Preparing Batches and Samples for Labs (1 hour) 11:00 am - 12:00 pm

With legal medical cannabis laws dating back 18 years now, product safety standards are the latest inclusion in today's regulated market place. This course will cover the proper protocols to setting up batch and lot number development, tracking, and sampling for laboratory screening ensuring product safety, purity, and proper identity. Reduce your companies product liability by implementing these simple practices that also allow for a successful product recall should it become necessary.
